

UTS Prize Conditions of Award Law Partners Personal Injury Lawyers Prize

Faculty: Law

This document sets out the conditions of award for the below prize ('Prize') and the obligations of recipients ('Recipient') and UTS in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZE NAME: Law Partners Personal Injury Lawyers Prize

2. PURPOSE

To recognise the best performing student in either subject 76045 Medicine and Law or 77734 Law and Medicine.

3. VALUE AND BENEFIT

3.1 Number of Recipients:

Usually, one (1) Recipient will be awarded the Prize at the end of each academic year.

3.2 Benefit/s to Recipient:

The value of the Prize to the Recipient is \$500. The Recipient will also receive a certificate of award.

3.3 Payment of benefit/s:

- The Recipient will receive one payment of \$500 by electronic funds transfer to his/her nominated bank account; and
- A certificate of award which will be presented to the Recipient at the annual UTS Faculty of Law Awards Ceremony. If the Recipient is unable to attend the Ceremony, alternative arrangements will be made.

4. ELIGIBILITY CRITERIA

The Recipient must be enrolled in a UTS award course and receive a result in either subject 76045 Medicine and Law or 77734 Law and Medicine¹ in the academic year for which the prize is being awarded.

5. RECIPIENT SELECTION CRITERIA, IN PRIORITY ORDER

- The prize will be awarded to the student with the highest final mark in either subject 76045 Medicine and Law or 77734 Law and Medicine in the relevant academic year.
- In the event that two or more eligible students have the same highest final mark, the following criteria will be considered:
 - a) Performance in subject 76045 Medicine and Law or 77734 Law and Medicine outside of formal assessment that demonstrates mastery of and engagement in the subject;
 - b) No previous attempts of subject 76045 Medicine and Law or 77734 Law and Medicine;
 - c) Overall academic performance in the student's course, including GPA, whether the student has failed other subjects, received academic cautions or had a finding of misconduct against them.

¹ If neither subject 76045 Medicine and Law nor 77734 Law and Medicine are not offered in the academic year, and the donor nominates another subject in their place, the Prize will be awarded to the student who receives the highest aggregate mark in the nominated subject according to the eligibility and selection criteria and selection process identified in these Conditions of Award.

6. SELECTION

- The student(s) with the highest final mark will be nominated by the Faculty's Admissions and Progressions Officer according to the eligibility and recipient selection criteria as provided in clauses 4 and 5;
- In the event that two or more eligible students have the same highest final mark, a selection committee of a minimum of two (2) people, Chaired by the Dean, Faculty of Law (or nominee) will select a Recipient based on the specified selection criteria in clause 5;
- The proposed Recipient will then by formally approved or declined by Faculty of Law Academic Board based upon the selection criteria in clauses 5 and 7.

7. OTHER CONDITIONS

- The Dean, Faculty of Law may decline to offer the award to a recipient who achieves the highest aggregate mark where the mark is less than 75.
- If neither subject 76045 Medicine and Law nor 77734 Law and Medicine are not offered in the academic year for which the prize is to be awarded, then the donor may:
 - o nominate another subject for that academic year; or
 - o decline to offer the award; or
 - o come to any other mutually satisfactory arrangement with UTS in respect of the prize.
