## Course description

Our UTS Bachelor of Laws has a clear-eyed focus: the law, how to apply it, and how to turn it into a career. As one of Sydney's leading law degrees, this course will help you build professional capabilities in all things law, as well as the 'soft' skills (problem solving, analytical thinking, spoken and written communication) required to get ahead in the workforce.

You'll become well-versed in the mechanisms - and quirks - of the Australian legal system, and you'll gain core skills in common law principles before you specialise. And if you're really set on starting your career as a legal practitioner in NSW as soon as possible, use your electives to complete your practical legal training and get ready for admission in just four years!

UTS Law offers the Bachelor of Laws standalone degree as a four-year program, or you can undertake a combined law degree with most other disciplines offered by UTS - science, IT, international studies, communications, and many more.
