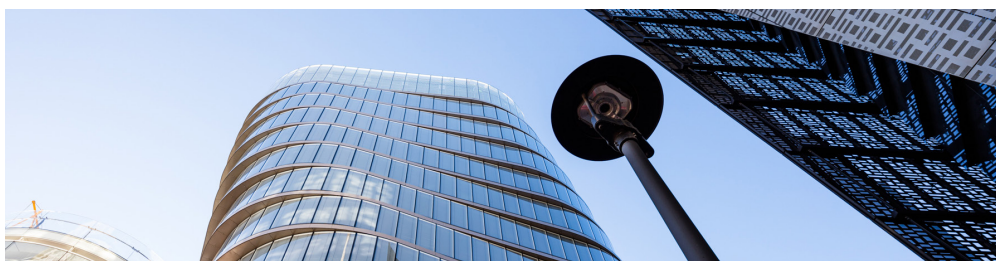


UTS Law Scholarships

International students undertaking a UTS Law program may be eligible for the following scholarships, grants and prizes.

Undergraduate scholarships*

Full tuition scholarships

Vice-Chancellor's International Undergraduate Scholarship

For high-achieving high school graduates completing an Australian Year 12 or comparable studies, and commencing an undergraduate program at UTS in Sydney.

Scholarship for Maple Leaf Education System Graduates from PRC

For high-achieving students completing the Canadian British Columbia Certificate of Graduation from Maple Leaf Education System in China and enrolling in an undergraduate program at UTS in Sydney.

This scholarship is currently under review and there may be changes to the scholarship in 2024.

Partial tuition scholarships

Scholarship for Gaokao Students from PRC – covers 50% or 75% of tuition fees

For high-achieving students completing the Gaokao in China, and enrolling in an undergraduate program at UTS in Sydney.

International Baccalaureate (IB) Scholarship – covers 50% of tuition fees

For high-achieving IB graduates commencing an undergraduate program at UTS in Sydney.

Scholarship for European Undergraduate Students – covers 40% of tuition fees

For commencing students from Europe enrolling in a UTS undergraduate coursework program.

Undergraduate Academic Excellence International Scholarship – covers 25% of tuition fees

For Australian Year 12 graduates or UTS-recognised high

school graduate commencing an undergraduate program at UTS in Sydney.

Diploma to Degree Scholarship – covers 25% of tuition fees

For students completing a Diploma or Higher Diploma qualification in selected countries in Asia.

UTS Foundation Studies Scholarship – covers 25% of tuition fees

For high-achieving students completing the UTS Foundation Studies program at UTS College, Sydney and enrolling in an undergraduate program at UTS in Sydney.

UTS MACC Undergraduate Scholarship – covers 25% of tuition fees

For high performing students from Malaysia commencing full-time undergraduate studies (excluding combined courses) who have a minimum overall GPA of 3.00 out of 4.00 or equivalent.

Undergraduate Tuition Fee Scholarship – covers 20% of tuition fees

For commencing students from Latin America, Africa and selected countries in Asia enrolling in a UTS undergraduate coursework program.

Chinese Undergraduate Tuition Fee Scholarship – covers 20% of tuition fees

For commencing students from P.R. China enrolling in a UTS undergraduate coursework program.

Diploma to Degree Pathway Scholarship – covers 20% of tuition fees

For students of UTS College from selected countries in Latin America, Africa, Asia and Pacific Islands who successfully complete a Diploma and articulate to a UTS degree directly from Diploma.

Postgraduate scholarships*

Full tuition scholarships

Vice-Chancellor's International Postgraduate Coursework Scholarship

For high-achieving bachelor degree graduates commencing a postgraduate coursework program at UTS in Sydney.

Dr Chau Chak Wing Scholarship (KTP Master Degree) – full tuition plus \$10,000 AUD per session (max. 4 sessions)

For students who have received or are enrolled at a selected UTS Key Technology Partner (KTP) university in China, to undertake a master's degree by coursework at UTS in Sydney.

Partial tuition scholarships

Postgraduate Academic Excellence International Scholarship – covers 30% of tuition fees

For high achieving commencing students enrolling in a postgraduate coursework program at UTS in Sydney.

UTS MACC Postgraduate Scholarship – covers 30% of tuition fees

For high performing students from Malaysia commencing full-time postgraduate studies who have a minimum overall GPA of 3.00 out of 4.00 or equivalent.

Onshore Postgraduate International Scholarship – covers 25% of tuition fees

For students from Africa, South Asia or South-East Asia who have completed an Australia bachelor degree or higher, and are applying for a master's degree by coursework at UTS in Sydney.

Chinese Postgraduate Tuition Fee Scholarship – covers 20% of tuition fees

For commencing students from P.R. China enrolling in a UTS postgraduate coursework program.

Postgraduate International Scholarship – covers 20% of tuition fees

For commencing students who enrol in a Master degree by coursework program and are a citizen of Hong Kong SAR, Japan, Mongolia, South Korea, Taiwan, or a country in the Africa, Latin America, South Asia, or South East Asia region.

LATAM International Postgraduate Coursework Scholarship – covers 25% of tuition fees

For students from Latin America enrolling in a postgraduate coursework program at UTS in Sydney.

UTS Grant for Master's by Coursework Students – \$3,000 towards first session

For students already in Australia and commencing a master's degree by coursework at UTS in Sydney.

Alumni advantage

Already graduated from a UTS degree? If you're thinking about returning to study at UTS, you could be eligible for a 10% saving on your tuition fees through the Alumni Advantage Program. This discount applies to full-fee paying courses and will be applied automatically when you enrol.

* Based on academic merit. Conditions apply. Course duration is the standard number of sessions and credit points required to complete the enrolled program on the basis of a full-time study load, as specified in the letter of offer for admission to the course.
