Message from Project Lead

Welcome to the first newsletter for the Palliative Care in Prisons Project for 2025!

We are excited to embark on a busy and productive year as we approach the culmination of the National Palliative Care in Prisons project. This year will witness the rollout of the co-designed National Framework for Palliative Care in Prisons and several valuable learning resources. We are committed to ensuring that the strategies and collaborations fostered by this project will continue to thrive beyond its completion.

Thanks to the invaluable contribution from 40 stakeholders into the first co-design National Framework Capacity Building Workshop held in Sydney (28-29th November 2024), our team has been diligently integrating the numerous suggestions made by stakeholders and refining the draft Framework. The next stage of the Framework development involves a Modified Delphi. We are currently working with a company specializing in Delphi studies to distribute the online Survey, so keep a key on your inbox for an invitation to contribute towards the National Framework before the end of March 2025. This survey will allow us to gather national feedback on the next draft of the Framework, ensuring it meets the sector's needs and expectations.

Thanks to Prof Megan Williams, Josie Newton and Monique Hooper for leading the conversations with the Aboriginal and Torres Strait Islander Engagement Group, who provided essential insights to ensure the needs of our First Nations people were considered and appropriately integrated into the Framework. We look forward to their wise advice and counsel as we refine the National Framework.

We are in the final stages of data collection for the project. With governance approval in Queensland, finally being secured we are keen to commence medical record audits in this State. Semi-structured interviews with justice health and corrections staff are ongoing, and we greatly appreciate everyone who has participated. Your contributions are invaluable in advocating for the needs of those on the ground, and in developing learning resources, as well as shaping the National Framework.

We are also working to secure a date for a one-day National Workshop with the Program of Experience in The Palliative Approach / Indigenous Program of Experience in the Palliative Approach (PEPA/IPEPA) teams. This workshop aims to equip PEPA/IPEPA with a detailed understanding of the unique prison context, enabling them to develop and deliver tailored, timely palliative care education in Australian prisons. Finally, we look forward to hosting further Community of Practice sessions in 2025. Please keep an eye out for calendar invitations.

CAPACITY BUILDING

Q STREAM

Figure 1 | Summary of review recommendations We would like to highlight the 2024 National Review of First Nations Health Care in Prisons: Final Report. The report presents evidence and key recommendations on the opportunities for systemic reform at the national, state and territory levels to improve health care delivery for First Nations people in places of detention.

The report findings have been guided by the review's key lines of enquiry, while also recognising that there are distinct challenges within the broader operating environment that impact on the ability for progress to be made in this area

Recommendations

Health and justice ministers agree to a set of national reform principles to drive action

Health and justice ministers investigate evidence provided to the review and take steps to cease any practices that violate prisoners' rights

Establish a National Partnership Agreement to govern the reform of First Nations health services in places of detention

Implement a national program of work for First Nations health care in places of detention, led by the National Partnership Agreement

The national program of work should address:

- National health outcome indicators
- National First Nations model of care
- · Continuity of care
- Innovative programs with proven
- success
- National quality standards and
- reporting framework
- Funding arrangements
- Reporting and data collection
- Workforce strategy
- Infrastructure strategy and standards

Facilitate the leadership of the Aboriginal community-controlled health sector in the policy, design and delivery of health services in partnership

Health and justice ministers pilot alternative, therapeutic models of custody for First Nations people, prioritising mothers and young people
