

UTS Prize Conditions of Award

Accounting for Good – Top First Year Prize for Bachelor of Business Administration

UTS BUSINESS SCHOOL

This document sets out the conditions of award for the below prize ('Prize') and the obligations of recipients ('Recipient') and UTS in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZE NAME: Accounting for Good – Top First Year Prize for Bachelor of Business Administration

2. PURPOSE

The Prize, a gift made between Accounting for Good and UTS, sets out to encourage students to aspire to academic excellence.

3. VALUE AND BENEFIT

3.1 Number of Recipients:

One (1) Recipient will be awarded the Prize at the end of each calendar year that the course Bachelor of Business Administration is offered.

3.2 Benefit/s to Recipient:

The value of the Prize to the Recipient is \$1,200. The Recipient will also receive a UTS Certificate of Award.

3.3 Payment of benefit/s:

- The Recipient will receive one payment of \$1,200 by electronic funds transfer to his/her nominated bank account.
- A certificate of award will be presented to the Recipient at the UTS Business School prize giving event.
- The Recipient may have an opportunity to undertake a paid work placement at Matrix on Board (Trading as Accounting for Good), or participate in a mentoring relationship, which is to take place at a mutually convenient time and as arranged between the Recipient and Matrix on Board Pty Ltd (Trading as Accounting for Good).

4. ELIGIBILITY CRITERIA

The Recipient must:

- have been a full-time or part-time student immediately prior to the selection of the Prize; and
- receive a result in the Bachelor of Business Administration in the session immediately prior to the selection of the Prize; and
- have completed one (1) year of full time study (equivalent to 48 credit points) and be commencing second year of the Bachelor of Business Administration.

5. RECIPIENT SELECTION CRITERIA

- The highest aggregate mark awarded of all students in the Bachelor of Business Administration satisfying clause 4.
 - In the event two or more eligible students have the same highest aggregate mark the Prize will be equally shared with consideration to no previous attempts of the subjects having been made by one of the students.

6. SELECTION

The Recipient will be nominated by the UTS Business School Faculty Board as per Clause 5, and approved by the Dean (or nominee).

7. OTHER CONDITIONS

Should UTS find itself unable to award this prize in any given year, UTS will consult with Matrix on Board Pty Ltd (trading as Accounting for Good) to amend the selection criteria (temporarily or, if agreed, permanently) to enable the allocation of the prize on the closest possible basis in accordance with Matrix on Board Pty Ltd (trading as Accounting for Good) original intentions.
