

UTS Prize Conditions of Award

City of Sydney Law Society Practical Legal Training Prize

Faculty: Law

This document sets out the conditions of award for the below prize ('Prize') and the obligations of recipients ('Recipient') and UTS in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZE NAME: City of Sydney Law Society Practical Legal Training Prize

2. PURPOSE

To recognise the best performing student in the UTS Graduate Certificate in Professional Legal Practice.

3. VALUE AND BENEFIT

3.1 Number of Recipients:

Usually, one Recipient will be awarded the Prize at the end of each academic year.

3.2 Benefit/s to Recipient:

- The value of the Prize to the Recipient is \$500.
- The Recipient will also receive a certificate of award.

3.3 Payment of benefit/s:

- The Recipient will receive one payment of \$500; and
- A certificate of award which will be presented to the Recipient at the annual UTS Faculty of Law Awards Ceremony. If the Recipient is unable to attend the ceremony, alternative arrangements will be made.

4. ELIGIBILITY CRITERIA

The Recipient must be enrolled in the UTS Graduate Certificate in Professional Legal Practice and have received a result in subjects 75424 Legal and Professional Skills, 75422 Transactional Practice, and 75423 Litigation and Estate Practice ¹ in the academic year for which the prize is being awarded.

5. RECIPIENT SELECTION CRITERIA

- The prize will be awarded to the student who achieves the highest aggregate mark of all students who completed subjects 75424 Legal and Professional Skills, 75422 Transactional Practice, and 75423 Litigation and Estate Practice in the relevant academic year.
- In the event that two or more eligible students have the same highest aggregate mark, the following criteria will be considered:
 - Overall academic performance, including whether the student has failed any subjects, received any academic cautions and rate of progression;
 - Whether any findings of misconduct have been made against the student;
 - Any other valuable contributions made by the student to the Faculty outside of academic achievement.

¹ If 75424 Legal and Professional Skills, 75422 Transactional Practice, or 75423 Litigation and Estate Practice are not offered in the academic year and the donor nominates another subject(s) in its place, the Prize will be awarded to the student who receives the highest aggregate mark in the nominated subject(s) according to the eligibility and selection criteria and selection process identified in these Conditions of Award.

6. SELECTION

- The student with the highest aggregate mark will be nominated by Progressions, Results & Conferral (SAU) according to the eligibility and recipient selection criteria as provided in clause 4;
- In the event that two or more eligible students have the same highest final mark, a selection committee of a minimum of two (2) people, chaired by the Dean, Faculty of Law (or nominee) will select a Recipient based on the specified selection criteria in clause 5;
- The endorsed Recipient will then be formally approved or declined by the Dean, Faculty of Law (or nominee) based upon the selection criteria in clauses 5 and 7.

7. OTHER CONDITIONS

- The Dean may decline to offer the award to a recipient who achieves the highest aggregate mark where the mark is less than 75.
- If 75424 Legal and Professional Skills, 75422 Transactional Practice, or 75423 Litigation and Estate Practice are not offered in the academic year for which the prize is to be awarded, then the donor may:
 - nominate another subject(s) for that academic year; or
 - decline to offer the award; or
 - come to any other mutually satisfactory arrangement with UTS in respect of the prize.
