

UTS Prize Conditions of Award Object: Australian Design Centre Mentoring Award

Faculty: Design, Architecture and Building

This document sets out the conditions of award for the below prize ('Prize') and the obligations of recipients ('Recipient') and UTS in regards to this Prize. The administrative processes to support awarding this Prize will be managed, and may be amended, in accordance with UTS Rules, Policy and Procedures.

1. PRIZETITLE/NAME

Object: Australian Design Centre Mentoring Award

2. PURPOSE

The aim of the award is to encourage students to use the power of design to engage critical issues facing the community, and is awarded to students who produce an exemplary design project in selected undergraduate degrees in the School of Design, and in the Masters of Architecture (C04235).

3. VALUE AND BENEFIT

3.1 Number of Recipients:

Usually one (1) recipient from C04235 Master of Architecture and three (3) recipients (one
each from Interior and Spatial Design, Integrated Product Design and Visual Communication)
from the School of Design will be awarded the Prize in each calendar year.

3.2 Benefit/s to Recipient:

The award will be in the form of admittance to the Australian Design Centre's (ADC)
mentoring program. This includes access to career mentoring and support from the ADC's
director and lead curator.

3.3 Payment of benefit/s:

- The recipients will be offered the opportunity to enter the ADC's mentoring program for a time period to be agreed and at a mutually convenient time as arranged between the recipient and the donor.
- The donor or the donor's representative will present a certificate of award to the Recipients at the Faculty's prize giving event.

4. ELIGIBILITY CRITERIA

To be eligible for the Prize, a candidate must be enrolled in one of the following courses, have completed the relevant subject(s), and met the relevant conditions in the year for which the award is made.

5. RECIPIENT SELECTION CRITERIA, IN PRIORITY ORDER

- Demonstration of design intent as evidenced by design studio project
- Ability to establish the critical positioning of the design work within the intellectual framework of the studio as evidenced by design studio project
- Academic merit

6. SELECTION

Master of Architecture

The coordinator of each Design Studio (total 22) subject will nominate 1 project for inclusion in the long list, based on the selection criteria above.

These will be presented to the course Director who will shortlist the top 6 projects, based on the selection criteria above.

<u>Undergraduate Design courses</u>

The top 3 students in each design studio, as outlined in the table above, will be shortlisted.

Selection committee and process

The shortlisted projects will be assessed against the selection criteria by a selection committee comprising: the donor or the donor's representative, the Master of Architecture course director for the architecture award and the Head of School of Design for the design awards.

7. OTHER CONDITIONS

7.1. Withdrawal from Agreement

Either party (UTS or ADC) may withdraw from this agreement with respect to future academic years (beginning March to end November) provided notice is given prior to the start of the academic year as displayed in the following table.
